**Subject : CUT-OFF DATE FOR THE RENEWAL OF OLD PSiRA  
REGISTRATION CERTIFICATES - 31 MARCH 2018**

**The Private Security Industry Regulatory Authority (PSiRA) hereby informs all Security Service Providers (Officers and Businesses) to renew their old and expired registration certificate by no later than 31<sup>st</sup> March 2018.** Failure to do so before the cut-off date will render your registration certificate invalid for employment or trading for business.

The Private Security Industry Regulatory Authority (PSiRA) rolled out the *Renewal of Certificates* project with effect from the 1<sup>st</sup> December 2014 as part of fulfilling its regulatory mandate in interest of public safety. The purpose of the project is to ensure that only legible registered applicants (security officers and businesses) receive the new certificate with new security features encrypted.

It is in the best interest of the public for the Authority to promote public safety through effective regulation of the private security industry. The Authority has a statutory obligation *"To protect the constitutional rights of all people to life, safety and dignity through the effective promotion and regulation of the private security industry"*.

After careful consideration and in the best interest of private security service providers and the public in general, the validity period of the old PSiRA certificate to the 31 March 2018. **Therefore, all security officers and businesses whose certificates bear the old PSiRA logo and/or have expired, will be considered to be invalid for employment or trading as from the 1 April 2018.**

Kindly note that no letter of good standing will be issued to businesses whose certificates have not been renewed. The renewal fee for PSiRA business certificate is **R290**. Key primary requirements for business renewal include:

- ***Old certificate or affidavit if lost***
- ***Annual fees paid up to date***

All Security Officers are still being expected to pay a renewal fee of **R40** for old and expired PSiRA certificate.
